What's "Abuzz" in Steuben County?

Have you heard the news, or buzz, shall we say? Steuben County landowners participating in the Soil & Water District's (SWCD) Urban Clean Water Indiana (CWI) Grant Program have been busy, like bees, installing practices geared towards helping wildlife and protecting water quality. Several projects either have been completed or are near completion. These native-scaping (planting with native and non-invasive adapted plants) and water-edge enhancement projects will help to:

- § Attract beneficial native animals by providing food sources & valuable habitat §
 - § Increase wildlife viewing opportunities §
 - Sometimes in the surface of the s
 - S Enhance the beauty of the landowner's yards and neighborhoods S
- Seeduce energy consumption and pollution (reduced amount of grass to mow!)
 Seeduce suspended solids & associated contaminants in runoff

Resource concerns of urban landscapes differ from those of rural landscapes. Impervious rooftops, roads, parking lots, and compacted areas of urban landscapes increases surface runoff; delivering sediment, nutrients, and other pollutants to receiving bodies of water. Impervious surfaces do not allow water to pass through or infiltrate. Plants in urban landscapes can be used to manage stormwater runoff, similar to how rain gardens use plants to capture runoff from surfaces such as rooftops, driveways, and patios.

The ecological service they provide is necessary for the reproduction of over 85% of the world's flowering plants, including more than two-thirds of the world's crop species. Pollinators are also keystone species in most land ecosystems; fruits and seeds derived from insect pollination are a major part of the diet of approximately 25% of all birds and of mammals (Xerces.org). Have you thought about what you could do in your landscape or small area of your yard that could benefit wildlife and help protect water quality?

- 1. Organic Certification Cost-Share Program (OCCSP): Organic producers and handlers can apply for federal funds to assist with the cost of receiving and maintaining organic certification. Applications for eligible expenses paid between October 1, 2019 and September 30, 2020 are due October 31, 2020. Certified producers and handlers are eligible to receive reimbursement for up to 50 percent of the certified organic operation's eligible expenses, up to a maximum of \$500 per scope.
- 2. The Coronavirus Food Assistance Program (CFAP): The deadline to apply for this program has been extended until September 11, 2020. CFAP provides direct relief to producers who faced price declines and additional marketing costs due to COVID-19. A range of commodities are eligible for CFAP, including cattle, milk, corn, hogs, corn, and soybeans. You can access the full list of eligible

- non-specialty, specialty, livestock, dairy, and wool commodities by visiting <u>farmers.gov/cfap</u>.
- 3. **Banking Information:** If you have changed banks or opened a new account, please contact us to update the information in our office. Payments will be issued for many of our programs soon, and you don't want your money floating around cyberspace without a home.
- 4. Marketing Assistance Loans (MAL): These low-interest loans provide interim financing to producers so that commodities can be stored after harvest when market prices are typically low, then be sold later when price conditions are more favorable. Wheat loans are available now See us for details if you would like to apply.
- 5. **County Committee Elections:** Ballots for our upcoming election will be mailed November 2nd to eligible voters in LAA 3. We have two candidates running for this position Chuck Howard and Ginger Peckhart. Make sure to cast your vote.

2020-2021 Tree Sale

The Indiana Division of Forestry announced the ordering process for 2021 will be open October 1, 2020 to May 1, 2021. The State Nurseries offer more than 40 species of native tree and shrub seedlings to be planted in Indiana for conservation purposes. Tree seedlings can be ordered using the online ordering platform or by completing an order form. To order online, visit: http://www.in.gov/dnr/forestry/3620.htm. Scroll to the bottom of the page for the link to order trees. Order forms can also be downloaded from the website; forms should be available online by late August.

The Steuben SWCD will again offer tree pick-up for county landowners. Trees are picked up at the nursery in the Spring & delivered to our office. We ask for a small donation for this service. If you would like your trees picked up in the Spring, complete the **3rd party pickup section** when placing your order (**Check** the Jasper-Pulaski box — write **Extension** next to Name — write **Steuben** next to County — Use **260-668-1000** x **1400** for the telephone number).

We congratulate our 2020 River Friendly Farmer Terry Dailey! The River Friendly Farmer Award has been presented by the Indiana Association of Soil and Water Conservation Districts and sponsored by the 92 local SWCDs, and Indiana Farm Bureau, Inc. since 2000. This statewide initiative recognizes farmers, who through good production management practices help keep Indiana's rivers, lakes and streams clean. Dailey Farms is a family owned farm in southwestern Steuben County. The primary conservation practices they utilize include no-till, grassed waterways, filter strips & forage/biomass plantings. These practices trap sediment and increase infiltration so sediment & nutrients can be reduced in surface runoff. Vegetated filters also offer diversity & cover for wildlife species. Terry Dailey/ Dailey Farms will be honored at our annual meeting next March. **CONGRATULATIONS DAILEY FARMS!**
