Indiana NRCS District Conservationists are Ready to Help Landowners

Farm bill program deadlines have been set for Indiana's agricultural producers who want to improve natural resources and address concerns on their land. Jerry Raynor, USDA-Natural Resources Conservation Service (NRCS) State Conservationist, announced that **December 18** will be the application deadline for the Environmental Quality Incentives Program (EQIP) and **January 8** will be the application deadline for the Conservation Stewardship Program (CSP) in Indiana.

EQIP is a voluntary conservation program available for agricultural producers. Through EQIP, NRCS provides financial and technical assistance to install conservation practices that reduce soil erosion and sedimentation, improve soil health, improve water and air quality and create wildlife habitat. Popular EQIP practices include cover crops, nutrient management, forest stand improvement, prescribed grazing and water quality improvement practices. Also included in this sign up are several state and national initiatives that address specific concerns within geographic regions of the state. While these initiatives use EQIP funding, landowners that apply for funding in one of the initiatives will not compete against the general EQIP funding pool.

"EQIP helps agricultural producers in a manner that promotes agricultural production and environmental quality as compatible goals," said Raynor. "Farmers can receive assistance to implement structural and management conservation practices that optimize environmental benefits on their working agricultural land while helping to increase their yields."

The state and national initiatives include the following:

- Historically Underserved Farmers: This fund category is for applicants defined as socially disadvantaged, veteran, limited resource or beginning farmer.
- National Organic Initiative: NRCS provides assistance to help producers implement conservation measures in keeping with organic production. Producers who are certified organic, transitioning to organic or exempt from organic certification are eligible for this initiative.
- National On-Farm Energy Initiative: NRCS provides assistance to quantify how energy can be used more efficiently to reduce input costs, increase productivity and reduce air pollutants and greenhouse gas emissions. This initiative offers assistance for Ag Energy Management Plans (AgEMPs) and certain energy conservation practices.

- Working Lands for Wildlife Initiative Monarch Butterfly: The Monarch Butterfly Habitat Development
 Project is a multi-state effort focused on increasing monarch habitat on private lands through plantings of milkweed and nectaring forbs as well as managing pesticide use in proximity to monarch habitat.
- Working Lands for Wildlife Initiative Bobwhite Quail:
 The goal of this initiative is to convert tall fescue and other non-native forages to native grasses and forbs and develop prescribed grazing plans to address the habitat needs of bobwhite quail and associated grassland/shrub land species. This category is available statewide on land which overlaps one of the Indiana DNR C.O.R.R.I.D.O.R.S. priority areas.
- Great Lakes Restoration Initiative (GLRI): NRCS and partners work with producers and landowners to implement voluntary conservation practices that improve water quality, restore wetlands, enhance wildlife habitat and sustain agricultural profitability in the Great Lakes.
- Resource Conservation Partnership Program (RCPP)
 projects: RCPP promotes coordination between NRCS
 and its partners to deliver conservation assistance to
 producers and landowners. NRCS provides assistance
 to producers through partnership agreements and
 through the Grasslands and Gamebirds (five focal

- regions located strategically throughout Indiana).
- Western Lake Erie Basin Initiative (WLEB): NRCS and partners work with producers and landowners to implement voluntary conservation practices that improve water quality, restore wetlands, enhance wildlife habitat and sustain agricultural profitability in the Western Lake Erie basin.

CSP is an important farm bill conservation program that helps producers who are already practicing good stewardship to take their natural resource management to the next level. The program helps to improve both their agricultural production and provide valuable conservation benefits such as cleaner and more abundant water, as well as healthier soils and better wildlife habitat.

"Farmers and forest landowners who enroll in CSP are going the extra mile to conserve our Indiana resources," Raynor said. "The actions they are taking on their land are making a more productive and sustainable operation over the long run."

Producers interested in EQIP or CSP should submit a signed application to the local NRCS field office. Applications submitted by the program deadline will be evaluated for this round of funding. Applicants must meet minimum eligibility requirements for EQIP and CSP. NRCS staff will work with producers to determine eligibility and, assess and rank each application to compete for funding.

Conservation at Work Video Series

The Natural Resources Conservation Service (NRCS) recently released a new video series called "Conservation At Work," which highlights farmers and ranchers who have benefited from implementing conservation practices on their operations.

The videos spotlight farmers, ranchers and forestland owners from across the U.S., who tell their conservation stories and how their practices have helped them protect and improve resources, while saving time and money.



Currently, there are 30 practices featured from across the nation, with more in development. Examples include: cover crops; forage and biomass planting; forest stand improvement; grassed waterway; nutrient management; prescribed grazing; tree/shrub establishment; waste storage facilities; etc. Want to explore different types of conservation? Farm Service Agency Updates Please call the office, (260-665-3211, ext. 2) for more details.

- Small Grains Certification Deadline: Producers who have fall-seeded wheat, rye, or other small grains for harvest or cover crops need to certify this acreage in our office by December 15, 2020. * Michigan has a November 15, 2020 deadline, so please keep this in mind if you farm any Michigan ground.
- LAST CHANCE The 2nd round of the Coronavirus Food Assistance Program (CFAP 2): The deadline to apply for this program is December 11, 2020. CFAP 2 provides direct relief to producers who faced price declines and additional marketing costs due to COVID-19. A range of commodities are eligible for CFAP, including cattle, milk, hogs, corn, and soybeans. Please let us know if you haven't already applied for this program and have crops (or a share of your operator's crops) or livestock.
- 3. Dairy Margin Coverage Program (DMC): If you are a dairy producer and would like to purchase and enroll in this Dairy insurance program, please let us know. Deadline to enroll is December 11th.
- Marketing Assistance Loans (MAL): These

- low-interest loans provide interim financing to producers so that commodities can be stored after harvest when market prices are typically low, then be sold later when price conditions are more favorable.
- Corn, Soybean and Wheat loans are available now - See us for details if you would like to apply.
- County Committee Elections: Ballots for our upcoming election were mailed November 2nd to eligible voters in LAA 3 (Salem, Steuben, Otsego, and Richland Townships). We have two candidates running for this position - Chuck Howard and Ginger Peckhart. Make sure to cast your vote by December 7, 2020.
- 6. **ARC/PLC Signup:** Agricultural producers can now make elections and enroll in the Agriculture Risk Coverage (ARC) and Price Loss Coverage (PLC) programs for the 2021 crop year. The signup period opened Tuesday, Oct. 13. These key U.S. Department of Agriculture (USDA) safety-net programs help producers weather fluctuations in either revenue or price for certain crops, and more than \$5 billion in payments are in the process of going out to producers who signed up for the 2019 crop year. Enrollment closes March 15, 2021.
