### I. CALL TO ORDER

The SWCD Board meeting was called to order by Steuben SWCD Chair Kayleen Hart at 5:01 p.m.

#### IV. COMMITTEE REPORTS

### a. Natural Resources/Technical Assistance

Beth Williams, Chair

- Agricultural Improvement Act of 2018 (Farm Bill) / NRCS / FSA
  - 1. Talking Points were provided in the Supervisors packets.
  - 2. Janel provided NRCS District Conservationist Arthur Franke's update since he was unable to attend the meeting. She reported: Jennifer Walker is Acting NRCS District Conservationist for Steuben County this week, May 10 May 14, 2021; NRCS Environmental Quality Incentives Program (EQIP) contract obligation is due May 28, 2021 Steuben County has 21 pre-approved applications; and Art plans on working on Conservation Reserve Program (CRP) re-enroll contracts and new offer contracts this summer.
    Kayleen Hart, Farm Service Agency (FSA) Program Technician, reported FSA is beginning to certify crops for the year; July 15th is the deadline. Producers will be required to schedule an

<u>-Southeastern Lake Michigan Basin:</u> St. Joe River West (HUC 8) (Lake Michigan) Sub-watersheds:

- 1. Pigeon Creek Watershed
  - a. Watershed Land Treatment Project (WLTP) Updates: Janel requested approval to make the cost-share payment for the completed 17.24-acre forage/biomass planting in the Otter Lake sub-watershed of Pigeon Creek, once the field verification has been completed. Total cost of the project was \$2,586.00. Janel will invoice the state for the payment.

A motion was made by Chuck Howard to approve the \$2,586.00 payment for the completed 17.24-acre forage/biomass planting in the Otter Lake-Pigeon Creek sub-watershed. Seconded by Craig Holman. Motion carried.

b. WLTP Wildlife Habitat Pollinator Planting Application: Janel presented an application for a 1.75-acre pollinator planting on a property located in the Silver Lake sub-watershed of Pigeon. Landowner would like to convert the area into wildlife habitat specific to pollinator species. The area is currently in switchgrass. Arthur Franke and Resource Conservationist Aimee Wentworth performed a site visit to assess the property and provide conservation planning assistance. Landowner was also provided information on how to properly establish a pollinator plot.

Chuck Howard moved to approve the 1.75-acre wildlife habitat pollinator planting in the Silver Lake sub-watershed of Pigeon Creek using the 2020 Pigeon Creek Lake and River Enhancement (LARE) Watershed Land Treatment Project (WLTP) Grant. Seconded by Beth Williams. Motion carried.

- 2. Friends of the St. Joseph River (FotSJR)
  - a. Aimee Wentworth participated in the April 22, 2021 meeting virtually. She reported meeting highlights, including the FotSJR Board action to sign the coalition letter for Senate Bill 389; the formation of a committee to review/discuss the St. Joseph River watershed inventory project (funding discussion tabled to May meeting); and a board action for a gold-level sponsorship (\$5,000) of the St. Joseph River documentary for public television. b. The next FotSJR has been scheduled for May 27, 2021.
- 3. St. Joseph River Basin Commission (SJRBC)
  - a. The SJRBC will hold their 21<sup>st</sup> Annual Symposium virtually on May 14, 2021. Staff will not be able to participate due to scheduling conflicts.
  - b. The next SJRBC quarterly meeting has been scheduled for June 3, 2021. Janel reported SB 389 was passed and enacted into law. As part of the law (relating to wetlands regulation), the statute created the Indiana Wetlands Task Force, which, includes among its members an individual who is a representative of the SJRBC. Since the recommendation was due June 1, prior to the quarterly meeting for discussion, the Commission's attorney suggested sending a letter to preserve SJRBC representation on the Task Force. At the June 3<sup>rd</sup> SJRBC meeting, the Chairman will request a retroactive approval of the appointment recommendation.
- iii. Western Lake Erie Basin (WLEB): St. Joe River East (HUC 8) (Lake Erie) Sub-watersheds:
  - Upper St. Joe River (SJR) Includes Fish Creek, Nettle, and West Branch Sub-Watersheds:

     a. The Clear Lake Township Land Conservancy asked the Steuben SWCD to provide a letter of support for a Midwest Glacial Lake Partnership application they are submitting. They are requested funds for automated samplers on the Harry Teeters and Cyrus Brouse ditches. The

automated samplers will collect/analyze water samples to assist with identifying what nutrients/sediments are entering Clear Lake and help with developing a plan of action to reduce nutrient inputs. Because the support letter was required prior to the SWCD May meeting, Janel drafted a letter and had Board Chair Kayleen Hart review and approve.

b. Janel shared a thank you note from ISDA District Support Specialist Jennifer Thum. The note thanked us for our continued support of their efforts in the WLEB. ISDA's Tri-State WLEB Phosphorus Initiative proposal was funded; the SWCD provided a letter of support for this project, committing in-kind technical assistance and support for project promotion and education/outreach events. Kate Sanders reported about \$8 million was allocated for this regional collaboration/partnership between Ohio, Michigan, and Indiana to address phosphorus concerns.

### iv. Entire County

### 1. District Cost Share

a. Janel requested approval to make the cost-share payment for the completed 1.0-acre interseeding project in the West Branch of Fish Creek, once the field verification has been completed. Total cost of the project was \$150.

Beth Williams made a motion to approve the \$150 payment for the completed interseeding project in the West Branch of Fish Creek. Seconded by Chuck Howard Motion carried.

#### 2. Steuben County Lakes Council (SCLC)

a. Janel participated in the May 1, 2021 meeting virtually. She reported meeting highlights, including the Crooked Lake dredging project and residents' concerns about lowered water levels during/after the sediment removal.

b. The next SCLC monthly board meeting is scheduled for June 5, 2021.

## 3. Steuben County/Urban (IDEM Rule 5/MS4)

a. A copy of the stormwater inspection report conducted at the Trine University – Golf Apartments building site on March 18, 2021 was provided for review. Corrective actions were required for deficiencies identified during the inspection, including stabilization and sediment control measures.

b. A copy of the Samfred Market Place Storm Water Pollution Prevention Plan was provided for review. It is a commercial development project for storage units on the north side of State Route 120, near the intersection of W State Route 120 and Lane 385 Big Otter Lake in Fremont.

They discussed tools available to create the best plan for weed management and cover crop selection/maintenance. A recording is available through the Allen County SWCD website.
- e. NE/NW New SWCD Supervisor Training April 20, 2021 (virtual): Beth Williams participated. She reported the training was worthwhile for individuals with no prior knowledge of SWCDs and their role.
- f. IASWCD Lunch 'n Learn: Envirothon April 21, 2021 (virtual): Aimee participated to learn about Indiana's Envirothon program for high school students. A recording is available through the IASWCD website.
- g. Elkhart County SWCD Rain Barrel Workshop April 21, 2021 (virtual): Janel and Aimee participated.

- h. Xerces Society Insect Apocalypse: What's Happening? April 22, 2021 (virtual): Janel participated in this webinar featuring Executive Director Scott Hoffman Black, who reported the latest science on insect declines and how everyone can incorporate invertebrate conservation into their lives.
- i. NE Region Urban Soil Health Program "Meet & Greet" April 28, 2021 (virtual): Janel participated in this meeting sponsored by Urban Soil Health Program Director Eliana Blaine. Meeting was held to provide an overview of the new urban program, introduce program staff, and discuss the Conservation Partnership's role in the program. A recording of the meeting is available through the Conservation Cropping Systems Initiative (CCSI).
- j. CCSI Strategies Moving Forward Webinar April 29, 2021 (virtual): Janel and Aimee participated in this CCSI meeting, held to share their new opportunities for increasing soil health adoption. Janel provided information about funding available through CCSI for outreach/education projects that target farmers who have not adopted soil health systems. Projects must target improved soil health on Indiana cropland with proposals being due July 1, 2021. Janel requested ideas from Board Supervisors as this funding is readily available. The Board discussed cover crop grow tubes or boxes for use at area co-ops and future educational events. Janel will have Aimee find additional resources on this type of educational tool. k. Prairie Heights School Day May 7, 2021: Aimee provided program assistance for the 1st grade class field trip at Prairie Heights Elementary. She lead a station to assist LaGrange County Parks & Recreation Naturalist Leslie Arnold. Aimee had students participate in the "Tree Factory" where they learn about tree needs and survival and act out tree parts.
