

# Cost Share Rates

*\* all cost share payments over \$600 are taxable per IRS mandate*

<u>Conservation Practice</u>	<u>Cost-Share</u>	<u>Payment Cap</u>
Critical area planting	80%	\$600/ac
Fencing <sup>1</sup>	80%	\$3/ft
Field Windbreak	80%	\$600/ac
Grassed waterway	80%	\$10/ft
Filter strip	Incentive Payment	\$650/ac
Heavy use area protection	80%	\$1500/site
Pasture and hay planting	80%	\$150/ac
Pollinator plot	80%	\$650/ac
Tree planting	80%	\$600/ac
Wetland development/ improvement	80%	\$2500/ac

*\* additional Conservation Practices available*

*<sup>1</sup>Fencing practices should be part of an approved prescribed grazing plan*

*Individuals interested in the Fawn River Watershed Reducing Soil and Nutrient Run-off Cost-Share Program must complete an application.*

*All applications/projects will be evaluated and ranked to prioritize BMP implementation, based upon the total soil erosion savings, phosphorus reductions, targeted areas that are HEL classified, etc.*

*All practices will be inspected for final approval by Steuben County SWCD staff and/or Natural Resource Conservation Service (NRCS).*

*Program sign-up will be on a continuous basis or until the funding has been obligated.*

## Best Management Practices

Best Management Practices (BMPs) are practices used to prevent/reduce nutrient runoff and soil erosion that impact water quality in water bodies and ultimately, the nearshore waters of Lake Michigan.

## Are You Eligible?

To qualify for cost-share you must meet the following requirements:

- Land where the BMP is to be installed/used must be located within the priority area in green:

Fawn River

*(See map to the right)*

- The cooperator will agree to follow Natural Resource Conservation Service (NRCS) standards and specifications for the practice
- If you do not own the land, you must have landowner permission and signature for application
- The date of purchase/installation must be AFTER the date of cost share application approval
