## **Managing Residential Stormwater in a Changing Climate**

Have you noticed weather patterns such as precipitation and temperatures changing, along with extreme weather events becoming more common? According to "Indiana's Past and Future Climate: A Report from the Indiana Climate Change Impacts Assessment," temperatures are rising, more precipitation is falling and coming in heavier downpours, and the last spring frost of the year has been getting steadily earlier. The assessment predicts wetter winters and springs by mid-century, while forecasted changes for summer and fall precipitation are less certain.

Why does this matter? It matters because of the increased risk of flooding and risk of increased amounts of fertilizer and sediment washing into nearby water bodies from both residential and agricultural areas, which negatively impacts water quality.

As a homeowner, what can you do to reduce the potential of flooding? Reduce stormwater from running onto your neighbor's property? Reduce the potential of fertilizer running into waterbodies? Answer: SOAK UP THAT RAIN!! Install a conservation practice to soak up the rain and reduce runoff.

When natural areas are converted to make room for development or smaller lake houses are replaced

with larger houses, we are introducing impervious surfaces (e.g., rooftops, roads, parking lots, and driveways) or surfaces where water can't infiltrate which changes the way water flows over and through the land. That's right, you have stormwater running off your yard! Hard surfaces create stormwater runoff. Small changes in the way properties are managed can have a big impact and help protect the

waterbodies we play in and depend upon.



Take steps to protect your home and community now – using simple residential practices such as: (1) redirecting down spouts, (2) installing pervious pavers or gravel, (3) installing rain barrels, (4) increasing the number of urban trees and shrubs, and (5) growing native plants to reduce the amount of water running off your property.

Redirecting down spouts can be as simple as adding a downspout extension to direct water to a vegetated area where water can better infiltrate. Pervious pavers or gravel are alternatives to traditional pavement and allow rainwater and melting snow to seep through and infiltrate. Rain barrels capture rainwater from roofs and can provide you with water for lawns, flowers, and plants. Increasing the number of trees and shrubs not only provides shade and aesthetics but the tree leaves, branches, and bark intercept and absorb rainwater and reduce erosion by slowing rainfall before it hits the ground.

In addition to the above practices, you could plant more native plants in your landscape. Growing native plants involves using "conservation landscaping" to convert areas of your lawn to beautiful gardens using native plant species. Compacted soil growing lawn grass does little to absorb runoff. By contrast, native species have deeper root systems which help increase infiltration and filter water. Native plants are also better adapted to the region's particular climate conditions; once they are established, they should require little watering.

# Indiana Conservation Groups Have Record Year for Conservation Practices, Again

Indiana landowners, for the second year in a row, set a record in the number of conservation practices to maintain soil health, according to the Indiana Conservation Partnership (ICP). The ICP, which works with Hoosier landowners to provide technical or financial assistance for the implementation of conservation projects, recently announced its 2023 conservation accomplishments. In 2023, landowners supported by the ICP installed more than 50,000 new conservation practices, up 3,000 from 2022. Last year's 47,000 conservation practices installed was also a record.

The ICP report showed that over the last year landowners helped prevent over 1.6 million tons of sediment, over 3.6 million pounds of nitrogen and over 1.8 million pounds of phosphorus from entering Indiana waterways.

In the fall of 2022, and emerging in the spring of 2023, Hoosier farmers planted more than 1.6 million acres of living cover, which includes cover crops and winter wheat. Cover crops and no-till practices implemented with ICP's assistance sequestered an estimated 41,000 tons of soil organic carbon, which is the equivalent to the carbon emissions of more than 30,168 cars.
